Chandrajit Banerjee (CB) is the Director General of the Confederation of Indian Industry (CII). In this post, he is responsible for the overall operations of CII.

He has held and also holds Trusteeship and Board Member posts in many Indian and global institutions of repute.

CB is a Member of a number of important Government Advisory Bodies at the National and State levels. As DG of CII, he is responsible for leading and contributing to many policy level dialogues and discussions to enhance the competitiveness of India Inc and towards the development of India.
